BSL Reseller Info Sheet

1. Bgrc in Brief

- It is a premier integrated destination resort located in Kuantan, Pahang
- It houses several attractions like themed water park, safari park, outdoor recreation park Active Academy and variety of hotel accommodations namely Caribbean Bay Resort, Arabian Bay Resort & Everia Villa Resort
- Bgrc is owned by Sentoria Group Berhad (SGB), a public company listed on the main board of Bursa Malaysia

2. BSL Reseller

- Bgrc is desirous to engage individuals that are keen to promote Bgrc's holiday packages to their friends & relatives, and at the same to earn extra income in carried out these promotional activities
- These individuals shall be referred as BSL Resellers, and they are neither partner, agent nor staff of Bgrc
- In addition to Bgrc, the BSL Reseller scheme may be extended to cover other resort cities including Bsrc, Mbrc and Lgrc upon their respective completion.

4. Rewards

- BSL Reseller shall enjoy several form of rewards, which may change from time to time;
- Base commission
- Monthly incentive
- Quarterly incentive

4a. Base Commission

- 8% of net revenue generated (i.e. after Govt tax, if any)

4b. Monthly Incentive

- Additional 2% if Reseller achieve monthly target of net revenue RM20,000 per month.

4c. Quarterly Incentive

- Additional 2% if Reseller achieve monthly incentive for all three (3) months in a particular quarter.

5. Commission Payable

- All client's payment are to be made before event date.
- Commission is payable monthly via bank transfer upon full payment from client and completion of event.

6. Eligibility

- Above the age of 18 years, may apply to be a BSL Reseller.
- However, direct family (parents & children) of any Sentoria staff are not allowed to be a BSL Reseller
